This document contains information and instructions on invoicing **Nokian Tyres s.r.o.**, **VAT number CZ45794375** (Additional tax registrations – Germany: DE261774835, Austria: ATU66334503, Poland: PL5263093467, France: FR96502698939). **Registered office address: V Parku 2336/22, 148 00 Prague 4, Czech Republic.** Please follow these instructions at all times to ensure accurate and timely processing of invoices.

<sup>\*)</sup> Postal invoice address should be used only for invoices sent via regular mail. Registered office address is required on invoice always regardless invoice sending method.

## Addressing invoices to Nokian Tyres s.r.o.:

- Only invoices with the <u>correct legal entity name</u>, <u>VAT number and registered</u> <u>office address</u> will be processed. Incorrectly addressed invoices will be discarded.
- The name of the legal entity (Nokian Tyres s.r.o.) has to be specified on the first line of the address field.
- All invoices must include a purchase order number and/or the name of a Nokian Tyres s.r.o. purchase contact.
- Only invoices along with relevant attachments should be sent to the invoicing addresses. Any other documents or material sent to the invoicing addresses will be ignored.

## Nokian Tyres s.r.o. receives e-invoices.

- The primary method of sending invoices to Nokian Tyres s.r.o. is e-invoicing.
- Our operating partner is Basware Oyj (BAWCFI22).

## In addition to e-invoices, Nokian Tyres s.r.o. offers suppliers the possibility of sending their invoices by e-mail in PDF format.

- Follow these instructions when sending invoices by e-mail in PDF format:
  - 1) Invoices are to be attached as PDF files, and each PDF file is to contain only one invoice. Invoices sent in any other format will not be processed.
  - 2) Only invoices should be delivered using this service any other information is discarded.
  - 3) If you have attachments for an invoice, they need to be in the same PDF file as the invoice itself.
  - 4) The PDF attachment file names may only contain the following characters:
    - [A-Z], [a-z], [O-9], [.], [\_]. Multiple PDF invoices can be included in one email and each PDF file will be processed as a separate invoice.

5) The maximum attachment(s) size limit is 5MB per e-mail.
