

## **Instructions for following the webcast during the Annual General Meeting of Nokian Tyres plc**

Shareholders must register for the Annual General Meeting of Nokian Tyres plc between 12:00 p.m. on March 18, 2025 (EET) and 4:00 p.m. on April 29, 2025 (EEST).

Shareholders registered for the General Meeting may also follow the meeting via a webcast. Following the webcast is not considered as official participation in the General Meeting and it is not possible for shareholders to ask questions, make counterproposals, address the meeting otherwise, or vote via the webcast, and following the webcast is not considered as participation in the General Meeting or exercise of shareholders' rights. Shareholders who intend to follow the meeting via webcast and wish to exercise their voting rights are referred to vote in advance or by way of proxy representation. A link to the webcast will be sent by Innovatics Oy no later than the evening before the meeting on May 6, 2025, either by e-mail or SMS, depending on the contact details provided by the shareholder when registering for the Annual General Meeting.

The webcast of the AGM will be carried out by the Inderes Plc's virtual AGM Service via videosync-platform, which enables following of the General Meeting through live webcast. In addition to a stable internet connection, following the webcast requires a computer, smartphone or tablet with speakers or, alternatively, a headphone jack for audio playback. It is recommended to use one of the following browsers for monitoring: Chrome, Firefox, Edge, Safari or Opera. Following the webcast on the Videosync-platform does not require the use or download of any specific software.
